

PUBLIC NOTICE OF CONSULTATION ON THE SOHAM AND BARWAY NEIGHBOURHOOD DEVELOPMENT PLAN - REGULATION 16 – THE NEIGHBOURHOOD PLANNING (GENERAL) REGULATIONS 2012 (AS AMENDED)

During April 2024, Soham Town Council formally submitted its Neighbourhood Plan (and supporting documents) to East Cambridgeshire District Council for independent examination, which includes a final round of public consultation. The plan sets out a vision for the future of Soham and Barway and planning policies that will be used to determine planning applications locally (within the Soham and Barway Neighbourhood Area).

In accordance with Regulation 16 of the Neighbourhood Planning Regulations 2012 (as amended), East Cambridgeshire District Council is inviting comments on the draft Soham and Barway Neighbourhood Plan and associated documents for the minimum required 6 weeks. The consultation period will be from **Tuesday 23 April 2024 to Monday 3 June 2024**.

The consultation is open to anyone to submit their representations.

The draft Soham and Barway Neighbourhood Plan and accompanying submission documents are available to download from the Document Library on the Soham and Barway Neighbourhood Plan page on our website at https://www.eastcambs.gov.uk/local-development-framework/Soham_and_Barway_neighbourhood-plan. A copy of the draft Soham and Barway Neighbourhood Plan is available for inspection at East Cambridgeshire District Council's customer service centre during normal opening times.

All comments must be received on or before **Monday 3 June 2024**. Late representations will not be accepted.

Once the consultation period has ended, the Neighbourhood Plan and other supporting material, together with the representations received, will be considered by an independent Examiner. Further details on the Examiner and the examination process will be made available in due course.
