Proposed additional conditions

This is in addition to the amendment of the premises licence application to reduce the hours of the licence

Proposal was to reduce the hours to 10.00 am to 02.00am

With up to 6 occasions hours per year hours to be extended to 10.00am to 04.00 am

General

An individual risk assessment will be carried out for external events including:

- The nature and style of the venue
- The activities being conducted there
- The location and
- Anticipated clientele

Staff Training

All staff authorised to sell alcohol shall be trained in :

- Relevant age restrictions in respect of products
- Prevent underage sales
- Prevent proxy sales
- Maintain the refusals log
- Enter sales correctly on the tills so the prompts show as appropriate
- Recognising signs of drunkenness and vulnerability
- The four licensing objectives, the licence and conditions in force under the licence.
- How to refuse service

Large Events

The Premises licence Holder will comply with the Event Management Plan submitted to and approved by the Licensing Authority and no changes will be made to the Event Management Plan without the prior written consent of the Licensing Authority.

Boxing and Wrestling (including MMA and other combat sports)

The Premises licence Holder will comply with the Event Management Plan submitted to and approved by the Licensing Authority and no changes will be made to the Event Management Plan without the prior written consent of the

Licensing Authority. The Plan must set out (but is not limited to):

(i) how fighters will be matched

- the measures that will be in place to ensure the safety and welfare of competitors; including medical facilities and qualified staff provision
- fighter details
- layout of the venue
- competition rules
- referee details including qualifications

in line with England Boxing Rule Book

Prevention of Crime and Disorder

Door supervisors shall be employed by the premises based upon a risk assessment carried out in relation to the following factors:

- (i) Size of the venue external or internal
- (ii) Expected attendance
- (iii) Type of event taking place
- (iv) Location of the premises
- (v) Time of year
- (vi) Special occasion (New Year, Halloween, Local events etc.)
- (vii) Premises Licence Conditions

The premises licence holder must submit to licensing and police a completed risk assessment as prescribed at least 28 days before any external event that is

- (i) carried on by any person not affiliated with the venue; and
- (ii) promoted / advertised to the public.

Public Safety

An incident log (which may be electronically recorded) shall be kept at the premises for at least six months, and made available on request to the police or an authorised officer of the licensing authority, which will record the following incidents including pertinent details :

- All alleged crimes reported to the venue or by the venue to the police
- All ejections of patrons
- Any complaints received
- Any incidents of disorder
- Any refusal of the sale of alcohol
- Any visit by a responsible authority or emergency service
- The times on duty, names and the licence numbers of all licensed door supervisors
- employed by the premises.

Dispersal

From no later than 1 hour before the cessation of an external event to the public, a member of staff shall be dedicated to monitor the dispersal of customers and ensure patrons do not contribute to anti-social behaviour in the vicinity.

Prevention of Public Nuisance

Any special effects or mechanical installations shall be arranged and stored so as to minimise any risk to the safety of those using the premises.

The following special effects will require 10 days' prior notice to the licensing authority:

- Dry ice and cryogenic fog
- Smoke machines and fog generators
- Pyrotechnics, including fireworks
- Lasers

- Explosives and highly flammable substances
- Real flame
- Strobe lighting.

Noise limiting device/ equipment following working with an acoustic expert will be installed and will operate at all times regulated entertainment takes place externally at the premises.

The device/ equipment will be of a type, in location/s and set at levels approved in writing by the appropriate officer of the Council.
